Terms and Conditions of Participation in the ATOMEXPO 2010 International Exhibition

For the purposes of these Terms and Conditions the following terms are used:

Exhibition: ATOMEXPO-2010 International Exhibition

Exhibition dates: 7-9 June 2010

Organizer: Atomexpo LLC

Exhibition venue: Manezh Central Exhibition Hall, 1 Manezhnaya Square, Moscow 125009, Russia; phone: +7(495) 926-28-28, 648-17-77, fax: +7(495) 648-13-33, 926-28-05.

To participate in the Exhibition, please, fill in this APPLICATION-AGREEMENT, sign it and submit to Atomexpo LLC before **20 April 2010** at the address: bld.38, 10, Bolshaya Tuskaya str., Moscow, 115191, Russia.

The signed APPLICATION-AGREEMENT may be sent by fax + 7 495 952 99 49 or by e-mail: atomexpo@rosatom.info with **mandatory hand over of the originals in two copies to the Organizer (before or during the Exhibition).**

PAYMENT PROCEDURE: Total cost of services to organize the Participant's participation in the Exhibition includes:

- payment for stand area;
- registration fee;
- payment for remote participation;
- payment for additional services as per attached requests.

The Participant shall pay by wire transfer against the invoices issued to the Organizer's bank account within ten banking days commencing the invoice issue date. Invoices are issued after the Organizer has received the signed APPLICATION-AGREEMENT.

The payment procedure is as follows:

An advance payment comprising 60% + registration fee shall be paid within **10 banking days commencing the issue of the invoice.**

Payment of the remainder 40% shall be made **before 10 May 2010.**

In case the Application is submitted after 20 April 2010, the Participant should pay 100%.

In case the payment is made after 5 May 2010 the Participant information is not published in the Exhibition Official Catalogue.

In case the Participant violates the exhibition service payment dates, the Organizer shall have the right to unilaterally refuse to fulfill this APPLICATION-AGREEMENT and do not allow the Participant to participate in the Exhibition.

Additional services requested by the Participant during the Exhibition shall be paid for against the invoices issued not later than 5 banking days after the Exhibition closing.

After the Exhibition, the Participant shall sign an Acceptance Record of the services provided. The Acceptance Record shall be signed within five days commencing its receipt or submits to the Organizer a reasoned refusal to sign it with the same period of time. If the Participant does not sign the Acceptance Record of the services provided or submits a reasoned refusal to sign it within five days commencing the date of its receipt, the services shall be considered accepted by the Participant.

RESPONSIBILITIES OF THE PARTIES: Rights and responsibilities of the Participants stipulated in this APPLICATION-AGREEMENT shall not be subject to transfer to another person. The Participant shall not have the right to place exhibits of third parties within its stand area without coordination with the Organizer. The Participant shall use the stand area only for the intended purpose and in accordance with the Stand Plan. The Participant shall disseminate advertising materials or carry out other advertising activities exclusively within the boundaries of its stand area. The Participant shall organize and operate its exhibition in a way that does not obstruct movement of visitors in aisles and pose a threat to or violate rights of other participants and visitors. The Participant shall reimburse the Organizer for damage caused to the Organizer's property as well as expenses incurred by the Organizer to compensate for the damage caused by the Participant to third parties' property. The Participant shall respect safety precautions, fire safety rules, industrial hygiene regulations in effect on the Manezh exhibition hall. The Participant shall not have the right to conduct activities which are prohibited or contradict to the applicable legislation of the Russian Federation during the Exhibition. The Organizer shall not be made liable for loss or damage to exhibits or tangible property owned by the Participant incurred in the course of assembly, disassembly and work of the Exhibition. The Organizer shall ensure general security of the exhibition hall from 18.30 till 09.00 of the next day; general cleaning of the common territory and aisles of the exposition; general advertising of the Exhibition; common lighting; general insurance of the entire Exhibition against natural disasters and theft (the Organizer independently determines the amount insured, insurance premium and deductible).

REFUSAL TO PARTICIPATE: The Participant shall submit a refusal to participate in the Exhibition in writing to the Organizer. In case a written refusal to participate in the Exhibition has not been received but the Participant did not take part in the Exhibition or a written refusal was received less than 30 days prior to the Exhibition opening, the Participant shall fully pay for the services under the APPLICATION-AGREEMENT. In case a refusal is received not later than 30 days before the Exhibition opening, the Participant shall be reimbursed for all expenses paid except for expenses the Organizer actually incurred in relation to the preparation of the Exhibition. The registration fee is not returned.

REDUCTION AND CHANGE OF REQUESTED AREA: In case the Participant wishes to reduce the stand area after the Organizer has signed this APPLICATION-AGREEMENT, but not later than 30 days before the Exhibition opening, the Participant shall pay a 50% forfeit of the difference of the stand area price resulted from the reduction of the stand area. The reduction of the stand area by the Participant in less than 30 days before the Exhibition opening is prohibited.

In exceptional cases the Organizer, after signing the APPLICATION-AGREEMENT, reserves the right to change the place and sizes of the area provided for the Participant.

CANCELLATION OR CHANGE OF DATES OF THE EXHIBITION: In case the dates of the Exhibition changed or it is cancelled by the Organizer and the Participant has been notified thereof not later than one month before the Exhibition opening the Organizer shall not be made liable before the Participant for losses the latter sustained due to the Exhibition cancellation. With that, the Organizer shall fully reimburse the Participant, on the Participant's request, for all cash amounts received from the Participant.

FORCE MAJEURE: The Parties shall not be made liable for a failure to fulfill or improper fulfillment of their obligations under this APPLICATION-AGREEMENT resulted from circumstances beyond one's reasonable control, i.e. extraordinary and unavoidable circumstances under the given conditions, including a fire, terrorist act, natural disasters, war, military actions of any nature, decisions of the state bodies. A Party that failed to fulfill or improperly fulfilled its obligations due to circumstances beyond one's reasonable control shall immediately inform another Party on occurrence thereof. Documents (references) issued by relevant competent authorities shall serve as proper evidence of existence of above circumstances and their duration.

INSURANCE: Insurance of exhibits, goods, personnel and other risks shall be carried out by the Participant independently.

SETTLEMENT OF DISPUTES: Disputes and disagreement between the Participant and the Organizer shall be settled through negotiations. Should the consent be not reached on the disputable issues, they shall be forwarded by the concerned Party to the Court of Arbitration of the City of Moscow. This APPLICATION-AGREEMENT shall be subject to the substantive law of the Russian Federation.

OTHER TERMS AND CONDITIONS: All requests for additional services shall be intrinsic parts of this APPLICATION-AGREEMENT. Regarding all other issues that are not covered by this APPLICATION-AGREEMENT the Parties shall be guided by the ATOMEXPO 2010 Exhibition Participant's Handbook and the applicable legislation of the Russian Federation.

This APPLICATION-AGREEMENT is made in two copies having equal legal effect, one copy for each of the Parties.

The Participant has familiarized with the ATOMEXPO 2010 Exhibition Participant's Handbook published on www.atomexpo.com.

TERM OF VALIDITY: This APPLICATION-AGREEMENT shall enter into force commencing the day of its signing by both Parties and shall remain in effect until the parties fully fulfill their obligations.
